By an order dated 5 September 2025 made in the matter of Empiric Student Property plc (the “Company”), the High Court of Justice of England and Wales has directed that the Company convene a meeting (the “**Court Meeting**”) of the holders of Scheme Shares as at the Voting Record Time (as each such term is defined in the scheme document published by the Company on 9 September 2025 (the “**Scheme Document**”)) for the purpose of considering and, if thought fit, approving (with or without modification) a scheme of arrangement proposed to be made pursuant to Part 26 of the Companies Act 2006 between (i) the Company and (ii) the holders of Scheme Shares (as defined in the Scheme Document) (the “**Scheme**”) and that the Court Meeting will be held at 10.00 a.m. (London time) on 6 October 2025 at the offices of Gowling WLG (UK) LLP, 4 More London Riverside, London, SE1 2AU at which place and time all Scheme Shareholders (as defined in the Scheme Document) are requested to attend.
